- 2) Declarant will not amend the Declaration in any way which would restrict or prevent the owner of the property from using the property for its intended use as a church, including but not limited to youth center, prayer chapel, administration center, community meeting room and residential cottages for ministers.
- 3) During the first five (5) years after date hereof, the property described above may not be further subdivided for commercial purposes except as may be approved by the Building and Village Review Committee or the Board of Directors of the South River Property Owners Association.
